
MEMBERSHIP SURVEY

ADVOCACY & POLICY

Medical Assistance in Dying (MAiD)

The CHPCA designed a position statement to clarify the role of hospice palliative care, in MAiD, within a legal framework across Canada. The CHPCA strongly advocates for universal access to high-quality hospice palliative care to address the suffering experienced by patients with a life-threatening illness and their families. The statement is broad-based and encompasses all service providers including volunteers and caregivers.

There's a new survey out for Canadians from the Canadian government asking for opinions on Medical Assistance in Dying (MAID). Your feedback is requested and will help to determine the changes in policy.

The Government of Canada is preparing to launch a full review of the MAiD law this summer in response to the recent Quebec court ruling. Updating Canada's MAiD law will expand eligibility for MAiD beyond people who are nearing the end of life, and could possibly result in other changes once the review is complete. This questionnaire offers Canadians the opportunity to share their views with the Government of Canada on this deeply personal and very important issue.
